Invitation for Bids

Invitation for Bids No: MARMA/NCB/06/078-079

1. **The Government of Nepal has allocated funds** towards the cost of **Construction of Durgeshwori School Building, Barku** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Durgeshwori School Building, Barku (MARMA/NCB/06/078-079)**. Bidding is open to all eligible as per Section V of bidding document.
2. **Marma Rural Municipality** invites sealed bids or electronic bids from eligible bidders for the construction of **Construction of Durgeshwori School Building, Barku** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 2,49,00,000 (Two Crore Forty Nine Lakhs Only)**.
 - Minimum Work experience of similar size and nature: **One Government project of RCC Framed Building with minimum value NRs. 1,33,00,000 (One Crore Thirty Three Lakhs Only)**.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidders should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document **i.e. NRs. 5000 (Five Thousand Only)** in the Project's Rajaswa (revenue) account as specified below.

6. Electronic bids must be submitted to the office of **Marma Rural Municipality, Latinath, Darchula** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon on 2079/03/02**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 2079/03/02** at the office of Marma Rural Municipality, Latinath, Darchula. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 4,95,000 (Four Lakhs Ninety Five Thousand Only)** which shall be valid for 30 days beyond the validity period of the bid.
