Marma Rural Municipality, Latinath, Darchula has allocated funds towards the cost of Construction of Tapowan Ma.Vi Parpada Building, Marma-4 Darchula and intends to apply part of the funds to cover eligible payments under the Contract for MARMA/NCB/Works/4/2080/081. Bidding is open to all eligible as per Section V of bidding document.
2. Marma Rural Municipality, Latinath, darchula invites electronic bids from eligible bidders for the construction of Construction of Tapowan Ma.Vi Parpada Building, Marma-4 Darchula under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 3,68,00,000 (Three Crore Sixty Eight Lakhs Only)
 - Minimum Work experience of similar size and nature: At least one contract of government project of building construction work within last 10 years with a value of at least NRs. 1,48,00,000 (One Crore Forty Eight Lakhs Only)
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2080/9/13 at the office of Marma Rural Municipality, Latinath, darchula. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of NRs. 10,00,000 (Ten Lakhs Only) which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
